Scope of this document.

This document sets out BASRaT's policy on the publication of Fitness to Practise (FtP) decisions. It should be read and considered as an extension of the following documents, and not in isolation:

- Raising a Concern/Fitness to Practise (FtP): Guide for the public and employers
- Fitness to Practise Guide: Membership Guide
- Fitness to Practise: Guide for Accredited Institutions
- Fitness to Practise for Cautions and Convictions

Introduction.

As holders of a Professional Standards Authority ``Accredited Register" (AR), we (BASRaT) have a duty to put protection of the public at the centre of our work. We do this in part through setting standards for registrants and keeping them accountable to those standards via our Fitness to Practise process.

BASRaT seeks to perform our functions in an open, transparent and proportionate manner. The circumstances and outcome of Fitness to Practise proceedings are matters of legitimate public interest and are therefore published on our website and registrants register entries. The publication of FTP decisions provides valuable information about the standards expected of registrants, assists service users to make informed choices and helps to maintain public confidence in BASRaT and the profession.

As with all decisions, we must be fair and proportionate, ensuring that the rights of registrants and others involved in cases are protected by disclosing only the required amount of information to fulfil our function.

Legal basis for publication.

Under General Data Protection Regulation (GDPR) BASRaT is required to demonstrate its Lawful basis for processing. In the case of publishing FtP decisions, our legal basis is Public task as the processing is necessary for BASRaT to perform a task in the public interest and to fulfil our official function as required by the Professional Standards Authority's standards for Accredited Registers, namely standard five. Additionally, upon registration and renewal of registration, registrants read and agree to the terms and conditions for registration which include agreement to this policy.

Schedule of publications.

Unless otherwise stated, details of complainants and any other third party will be anonymized in publications. The information published publicly will be the minimum amount that is deemed proportionate and necessary to satisfy the public interest.

Decisions to withhold information or not publish.

BASRaT retains the discretion to decide exactly what is published and will consider exercising that discretion if the impact of publishing information would be disproportionate.

This may arise where publication would:

- Disclose confidential information about a person's health.
- Disclose legally privileged or confidential information.
- Create a significant risk of breaching the Article 8 ECHR right to privacy and family life.
- Prejudice another investigation or other legal proceedings.
- Disclose information which may hinder the performance of BASRaT's functions.
